## What Are Your Rights?

As a victim of a crime, you have rights under the Crime Victim Rights Act in the Michigan Constitution. The following is a summary of these rights.

- To be treated with fairness and dignity throughout the criminal justice process.
- To have reasonable protection from the defendant throughout the court process.

### **The following are your rights during prosecution, upon your request only.**

- To receive notification of any scheduled court proceedings and changes to that schedule.
- To speak with the prosecuting attorney before the case is resolved.
- To be present in the courtroom after you testify at all hearings.
- To make an oral or written Victim Impact Statement at the Sentencing Hearing
- To know that the Court can order restitution at sentencing.
- To be informed about the conviction, sentence, imprisonment, and release from jail or prison of the defendant.
- To be notified of the status of an appeal filed in your case.

Victims of a crime will be mailed an Activation of Rights form to request their rights. The form can also be found on our website.

### **Crime Victim Compensation**

The Michigan Crime Victim Compensation Board may help pay for expenses that result from the crime. Please call our office and ask about the Crime Victim Compensation Application. The following is a list of costs that they may be able to help with.

- Reasonable and necessary medical and counseling services
- Loss of earnings due to physical injuries
- Loss of support to dependents of homicide victims
- Funeral and burial expenses
- Crime scene clean-up (for homicide crimes only)
- Grief counseling (for homicide crimes only)
