### Requirements:

1. Front yard fences may only be decorative. Maximum allowable height is 4 feet. (Corner lots have 2 front yards)
2. Fence shall not be constructed of or contain barbed or razor wire, electric current, or charge of electricity.
3. Rear yard fences-Maximum allowable height is 6 feet.
4. No fences allowed in Right of Way
5. Please complete back side of permit.

Approval of this permit is for **zoning compliance only**. The property owner is solely responsible for making sure that the fence is installed in accordance with the zoning ordinance and located on their own property. If you do not know where the property lines are then a State of Michigan licensed surveyor should be contacted to locate them.

**TO THE APPLICANT-** You will be notified within 10 business days (unless otherwise communicated) as to the status of your application. If your project is denied, you will be notified as to the reasons why. If approved, you will be issued an invoice. Once paid you will be issued your permit and work may begin. Please make sure that you have completed, signed, and submitted all the necessary paperwork as to not delay your approval and start date.

Incomplete applications, contractor registration status issues, or missing plans or information, will slow application timeline and risk return of application


